- 1. An R-of-O Title Holder who wants to apply for Consent to Assign shall apply with this CTA form.
- 2. The Applicant (the Assignor) shall also complete ROI/ROO form with the details of Assignee.
- 3. Evidence of Payment needs to be submitted with the completed application form (CTA) and the required documents (see details above)
- 4. The Stamping and Registration Fee of 2.5% of Consideration is due after the evaluation of the property.
- 5. If a new Offer of Terms and Conditions or a new C-of-O are required, the Assignee must apply for a Replacement of Offer of fresh C-of-O with the ROI/ROO form.
- 6. The key steps in the Replacement process are described on the ROI application form please refer to the form.
