### MAKING PAYMENTS VIA BANK TRANSACTIONS

- Step1: Visit any Bank branch with this Notice and request to pay Zamfara State IGR Bill Via Pay Direct, REMITA, E-Transact or E-Bill using your ZIRS TIN
- Step 2: Enter ZIRS TIN or Notice Number to validate and load details
- Step 3: Click Continue to preview and Confirm details.
- Step 4: Make Cash or Cheques payment Ensure/request that your payment is processed on any of the payment gateways.
- Step 5: Make sure to obtain Receipt/teller at that point of payment.
- Step 6: Bring the teller and the Receipt to ZIRS Head office or any of our Tax Station to obtain E-receipt. Or you can pay at Banks that host our Model Tax Stations

Note: A separate bank teller should be raised for each item on the CDN.

#### OR

#### **BANK TRANSFER**

You can transfer each payment into Zamfara State Consolidated Revenue Accounts 6. Repeat step 4&5 to pay for other items on the independently.
