- 1. To transfer a deceased R-of-O Title Holders Property by a Devolution Order, the legal Relative must apply with this DVO form.
- 2. The Applicant (the Relative) must also complete a ROI/ROO form with the details for him self.
- 3. The Registration Fee of 2% of the assessed value after the evaluation of th property is required.
- 4. If a new Offer of Terms and Conditions or a new C-of-O are required, the Relative must apply for a Replacement of Offer for fresh C-of-O with the ROI
- 5. The key steps in the Replacement process are described on the ROI application form please refer to this form.
