<u>Please note:</u> Plot Extension is for 1 registered (titled) Land and 1 unregistered (untitled) Land. R-of-O Title Holder with registered Titles who want to extend their Property into a registered Land (2 registered Title), shall apply for Plot Merger with the Application Form for Plot Merger MPI or MPO.
