A proof of Ownership such as Change of Ownership and Clearance Form from Local Government or Allocation Letter for the Land NOT registered is required. The Application Form PEX shall be attached to the ROI Private Individuals or ROO Organisations. ZAGIS Town Planning Officer will contact the Applicant for a Site Inspection.

Please note: Plot Extension is for 1 registered (titled) Land and 1 unregistered (untitled) Land. R-of-O Title Holder with registered Titles who want to extend their Property into a registered Land (2 registered Title), shall apply for Plot Merger with the Application Form for Plot Merger MPI or MPO.
