
**WHEREAS** the Government of Zamfara State in creating enabling environment for businesses and at the same time improving the regulatory environment for driving private sector investment in digital infrastructure as well as improving the internally generated revenue in the State, had issued an Executive Order No. 9, 2023 dated 20<sup>th</sup> day of December, 2023, Prescribing Right of Way Charges payable by the telecommunication service providers to the State.

**AND WHEREAS** in an effort to make a strong push for a quality service delivery in the telecommunication industry and to compliment the effort of telecommunication service providers in providing quality and affordable services in strengthening infrastructural development and guarantees the ease of doing business in the State, the Zamfara State Government is desirous of granting a waiver to the telecommunication service providers in Right of Way Charges

**NOW THEREFORE** in the exercise of the powers conferred on me by Sections 5 (2) and 315 (2) of the Constitution of Federal Republic of Nigeria, 1999, (as amended) and section 87 of the Zamfara State Consolidated Revenue Law No. 7, 2020 (as amended) and all other powers enabling me in that behalf, **I, Dauda Lawal, Executive Governor, Zamfara State**, do hereby issue an Executive Order as follows:

1. This Executive Order may be cited as the Zamfara State Government Waiver on Right of Way Charges Order No 14 ,2024 and shall come into operations on the ..... day of ..... 2024.
2. From the commencement of this order –
  - (i) Right of Way Charges to telecommunication service providers as prescribed in an executive order No. 9, 2023 is waived in Zamfara State for a period of four years on such terms and conditions stipulated in the schedule to this executive order.
  - (ii) The Zamfara State Internal Revenue Service and Zamfara State Urban and Regional Planning Board or any other Agency responsible for such collections shall comply with the provisions of this Order as communicated to the telecommunication service providers in the Schedule therein.
  - (iii) The Attorney General shall take legal action against any person that fails, neglects or refuses to comply with this Order.
  - (iv) The Executive Order No. 9, 2023 is suspended for a period of four years commencing from 29<sup>th</sup> day of February, 2024.
